

1. Executive Summary

The IVVES framework is an online platform that acts as a front-end for the public IVVES artifacts to the people outside of the consortium. The aim of the framework is that all the public IVVES outcomes come with a well-defined and clear package of training and possibilities to try them out (experiment with them). Besides the framework, the "IVVES Integrated Methodology for V&V of ES" aims to describe how the results from WP2, WP3 and WP4 can be combined to form a common process. A first approach to this methodology was described in previous version of this document (D5.3). In that document, a first view of the components, libraries and techniques preliminary integrated as part of the validation and verification workflows was provided. Also, the solutions that could be applied to any of the domains, were shown.

The intuition is that, starting from a domain-specific approach, we firstly showed a clear domain-focused V&V toolchain references, that could guide third parties to set up a specific learning (and experimentation) path.



As a second iteration, we propose to complement this first approach with a view to identify, in a more intuitive way, when an artifact is relevant for a specific development cycle and what aspects it covers in terms of artificial intelligence application. The aim is to help any developer or external entity to determine which tools are relevant for their use case. The selection of tools (or sets of tools) should allow for the filtering of artefacts according to the use (environment) in which they are to be deployed. In other words, it should be possible to filter by: languages, frameworks, scope, licensing restrictions...

2. Introduction

The document is showing the libraries, tools, components, techniques from (WP2, WP3, WP4) that have been tested to solve the V&V challenges and requirements.

3. IVVES for Cyber-security (F-SECURE)

3.1 Description of requirements and challenges.

The requirements and challenges identified in this domain, are related to the use cases described in "D1.1 – Detailed Description of Requirements from Use Cases". The components, techniques, tools and libraries designed and/or improved and integrated at this stage are covering three sections:

- Security events analysis.
- Test selection and prioritization analysis.
- Automated tests generation and application model inference.

3.2 Description of the Methodology for V&V of ES in this domain.

3.2.1 Security events analysis

DENDRIFT: A DRIFT-AWARE ALGORITHM FOR HOST PROFILING

DenDrift is a tool that can detect three prevalent forms of concept drift and improve the quality of clustering algorithms. Can effectively distinguish between outliers and drifts and is supplied with a concept drift simulator:

- Based on Gaussian mixture models
- Can simulate three forms of drift with user defined magnitudes and durations
- Allows users to adjust the number of clusters before and after the simulated drift

DenDrift has been tested as part of the V&V process for "FS2: Quality assessment and reproducibility of unsupervised ML models", specifically for Model Quality (T2.1).

COMMAND LINE QUALITY

Computer vulnerabilities can be exploited in a variety of ways. Malicious actors may use a specific exploit, a secret pathway to enter a computer system, or a misconfiguration in one of the system components. In most of these attacks, malicious actors run malicious programs through shell commands. One way to detect malicious activities on a machine is by analyzing the structure of shell commands. "Command Line Quality" is a hybrid approach that combines rule-based systems (based on expert opinions) and Machine Learning to solve the problem. That is, given a new shell command, Command Line Quality finds other similar shell commands. This helps in creating clusters of similar commands and classifying them as safe or malicious. "Command Line Quality" has been tested as part of the V&V process for "FS3: Utilization of complex textual data for machine learning applications", specifically for Training Data Quality (T2.2).

DATA QUALITY WRAPPER

Data Quality Wrapper is a tool that includes tabular statistical verification methods and NLP techniques for assessing quality of tabular and unstructured text data. This solution addresses the challenge of automating the pre-processing step in structured and unstructured (data, together with data visualization step for both and pre-processing of text data It is of crucial importance to understand the underlying assumptions of data in order to prepare it for training an Al model.

"Data Quality Wrapper" has been tested as part of the V&V process for "FS3: Utilization of complex textual data for machine learning applications", specifically for Training Data Quality (T2.2). The DATA QUALITY WRAPPER is a general-purpose tool, and is being tested in several domains. The results will be provided in the next version of the document (D5.4).

CODE QUALITTY PLUGIN uses machine learning to predict risky code areas by if a commit contains code that could result in defect. It has been tested as part of the V&V process for "FS4: Optimization of tests execution", being related to ML-driven Testing (task 3.1), investigating data sources to detect code quality with machine learning and also related to Testing with Uncertainties (task 3.2), testing risky pieces of code and predicting code quality defects. The plugin is a general-purpose tool, and is being tested in several domains. The results will be provided in the next version of the document (D5.4).

3.2.3 Automated tests generation and application model inference

TESTAR

TESTAR is an open-source tool for scriptless test automation through graphical user interface (GUI). It can be used for monitoring too, especially with state model inference and analysis. The idea is to infer state models by observing the GUI of the system under test during automated testing. The models are inferred from consequent version of the same system, and changes between versions can be detected by comparing the models. TESTAR has been tested as part of the V&V process for "FS5: Automated test generation", being related to ML-driven Testing (task 3.1) and Online Testing & Monitoring (task 3.3), especially with state model inference and analysis.

5. IVVES for Healthcare (PHILIPS)

5.1 Description of requirements and challenges.

The main objective is to improve effectiveness and efficiency of the V&V activities. Current challenges to address are:

- Automation of test case creation based on real customer use. Through analysis of log files, we try
 to extract the operational workflows that represent most common customer use cases including
 the typical scan protocols used with these workflows.
- For training the algorithms and for verification activities we need clinical data sets. The amount of
 clinical data needed, limitations with scanning on 'volunteers' or using hospital data and privacy
 rules restrict availability and possibility in using real clinical data and therefore we're exploring
 possibilities in use of synthetic data.
- Our platform concept and following an evolutionary/incremental development strategy requires tests to be repeated/executed on different HW configurations and increases the level of regression testing with each development cycle. How can we use AI for smart selection of (regression) tests across applicable HW configurations?
- Our defect management process has several decision-making steps. Can Al support and as such increase efficiency of the decision-making process for defects?

5.2 Description of the Methodology for V&V of ES in this domain.

OPERATIONAL PROFILE DRIVEN TEST FRAMEWORK

The OPERATIONAL PROFILE DRIVEN TEST FRAMEWORK being developed is a proprietary Philips tool, tuned for the MR product, to extract and execute operational workflows. The process the tool supports will be shared with and can be applied in any of the IVVES domains.

3D GAN ALGORITHMS

Currently, 3D GAN algorithms are being experimented to generate 3D MR images of the brain.

The main goal is to improve the V&V techniques through the entire development and testing lifecycle of the ING applications (mobile and web) for individual customers by replacing manual work with AI-based V&V tools in the development and testing lifecycle. For example: facilitate error detection and correction in a new release candidate and advise on go-live.

6.1.2 V&V for ESG investment system (CCTL/NETCHECK)

The main goal is to provide an effective tool to assess and validate performance and reliability of ML-enabled systems for ESG scoring based on new Albased V&V techniques; increasing the adoption of ML-based services from Home Offices, Brokerage Agencies and Fintech companies.

TESTAR is an open-source tool for scriptless test automation through graphical user interface (GUI). TESTAR has been tested as part of the V&V process for "UC4- Finance domain: Improved V&V techniques with AI", aiming to provide improved ML algorithms for action selection, and using state model inference for automated change detection. TESTAR tool has been extended to support testing of mobile applications and evaluated by using it for testing ING mobile banking app. The early results indicate that TESTAR complements the existing scripted GUI testing by increasing the combined coverage.

7. IVVES for Industrial Automation

7.1 Description of requirements and challenges.

7.1.1 System Level Regression Test Analysis (ABB)

The ABB robot controller software is a long-lived evolving system with its roots in the early 90s. It's a one-size-fits-all open system which can be customized to fulfil a lot of different customer cases, such as picking, arcwelding, spot welding, painting, etc. The robot controller software has several configurations, and all different configurations make it hard to measure and predict how the hardware/software resources are utilized. When a problem arises, it is also hard to tell in which software build the problem was introduced.

In IVVES, we would like to measure performance and system utilization in each new daily build of the robot controller software. Analyse the deviations between builds. Decide if the deviations are within normal fluctuation or if they are suspicious.

Performance testing at ABB is currently a manual activity which is done after functional testing and before releasing a new release of the application. The activity is labor intensive and it is hard to measure and predict how the hardware/software resources are utilized. When a problem arises, it is also hard to tell in which software build the problem was introduced.

7.2 Description of the Methodology for V&V of ES in this domain.

7.2.1 System Level Regression Test Analysis (ABB)

The solutions that are being developed for the ABB's use-case are based on the algorithms and techniques implemented in the following tools:

RELOAD (by RISE)

RELOAD is an automated machine-learning assisted load testing tool that can generate effective and efficient workloads to identify performance bottlenecks.

ACTA

ACTA is an automated test generation method called ACTA for black-box performance testing. ACTA is based on active learning, which means that it does not require a large set of historical test data to learn about the performance characteristics of the system under test. Instead, it dynamically chooses the tests to execute using uncertainty sampling. It has been tested as part of the V&V process for "UC5-Industrial Automation: System Level Regression Test Analysis", being related to ML-driven Testing (task 3.1), implementing a deep learning algorithm for performance test generation.

Currently, MACAU is experimented with in a number of de-facto standard toy cases, equities ranking in **financial** domain, energy demand prediction as a part of a hybrid model solution, synthesis pathway analysis in synthetic biology, to name a few, in addition to we being open for interesting IVVES challenges So far, the method has worked exactly as expected out of box which can be sometimes abnormal in the realm of machine learning Especially uncertainty modelling seems to be promising.

9. IVVES ToolViewer and Navigator Mockups

To help any third party (ML developer, Al researcher) to better understand how a specific tool is relevant for a specific Al development lifecycle, we propose a complementary view to better support the analysis and selection of tools. For this, for every main block in the project (related to results from work packages):

- Validation Techniques for ML
- Validation Techniques for Complex Evolving Systems
- Data-Driven Engineering

we provide a high-level view, where all the tools are presented, and two functionalities to navigate through the tools landscape:

- an advanced search, to filter tools regarding usage, restrictions, framework or languages restrictions, compatibility...
- a zoom approach to narrow the search in a specific area.

Below as follows, the main mock-ups are shown. The main view will give access to the three main areas:

- Validation Techniques for ML
- Validation Techniques for Complex Evolving Systems
- Data-Driven Engineering

And also, will provide (if available) videos on hands-on trainings, experiences, workshops related to domain or use-case approaches, that could give a context to the user.




Figure 1 Main view: access to the different areas covered by tools/artifacts developed in IVVES

For every area, a navigation tool will allow to:

- Get an overview of all the topics covered in every area.
- Get an overview of what tools are available.
- Get a detailed information of any tool, focusing on how this tool can be used by any third party and what other tools are related to this tool. If the tool is interesting, it can be tagged for further searches.




Figure 2 Navigation tool for artifacts released in WP2




Figure 3 Navigation tool for artifacts released in WP3




Figure 4 Navigation tool for artifacts released in WP4

Finally, the search of the toolchains can be narrowed with advanced search capabilities:




Figure 5 Example of advanced search in Complex Evolving Systems

The proposal, which allows not only to select several relevant artefacts, but also to establish advanced searches (taking into account frameworks restrictions, licences...), is a key tool for the impact of IVVES to go beyond the capabilities of each artefact separately.
